## Record of Discussions of the 8th meeting of the Oversight Committee held virtually on 25<sup>th</sup> February 2025

Date: 25th February 2025, 04:00 p.m.

Mode: Virtual mode via Webex

The eighth meeting of the Oversight Committee was held virtually on 25<sup>th</sup> February 2025 under the Chairpersonship of Chair and Vice Chair, Oversight Committee of India CCM. The agenda of the meeting and the attendance sheet may be found enclosed at *Annexure-1* and *Annexure-2* respectively.

#### Major Discussion/Action Points are as follows:

- 1. An update on the action points from the 7th Oversight Committee (OC) meeting was provided, and it was informed that the inputs from Program Divisions on the OC reports have been received and the OC was requested to share the final reports for Delhi and Chhattisgarh by 28th February 2025.
- 2. It was noted that as on date, the C19 RM and GC7 Quarterly Progress Reports have been received from all PRs except CTD. The Oversight Committee members were requested to review their respective disease components and provide their feedback on the progress reports which will subsequently be shared with the PRs.
- 3. It was informed to the Oversight Committee that India CCM has been receiving some complaints regarding SR and SSR selection. A view was sought from the Oversight Committee if such complaints can be taken up under the purview of the Oversight Committee. The Oversight Committee members responded that the OC has no role in the selection of SRs and SSRs. Therefore, dealing with such complaints was beyond the purview of the Oversight Committee.
- 4. It was informed that the approval for a physical PR Desk Review was not received within the prescribed timeframe. Therefore, a virtual disease component-specific PR Desk Review would be planned to be conducted twice weekly in two separate slots each day, starting with C19 RM.
- 5. A template for the PR Desk Review to be developed for updation by the PRs.
- 6. The 9th virtual Oversight Committee meeting to be held coinciding with the last day of the PR Desk Review meeting.
