# Record of Discussions of the 9th meeting of the Oversight Committee held virtually on 11<sup>th</sup> April 2025

Date: 11<sup>h</sup> April 2025, 12:00 p.m.

Mode: Virtual mode via Webex

The ninth meeting of the Oversight Committee was held virtually on 11<sup>th</sup> April 2025 under the Chairpersonship of Chair, Oversight Committee of India CCM. The agenda of the meeting and the attendance sheet may be found enclosed at *Annexure-1* and *Annexure-2* respectively.

#### Major Discussion/Action Points are as follows:

- 1. An update was provided on the action points from the 8th Oversight Committee meeting. It was noted that except the Malaria Action Taken Report from the State of Chhattisgarh, there are no pending action items.
- The Chair of the Oversight Committee requested the India CCM Secretariat staff to share consolidated recommendations for all Principal Recipients (PRs) from the C19 RM and GC7 PR Desk Review conducted by the Oversight Committee.
- 3. The Oversight Committee emphasized the need for increased engagement with PRs through participation in their national and state-level trainings, reviews, and evaluations.
- 4. In view of the current meetings focussing on KPIs and concerned performance, the Committee highlighted the importance of addressing gender and equity issues during review meetings with PRs and during field visits. A sub-committee of Dr. Ramila Bisht, Dr. Nandini Kapoor, and Dr. Deepika Srivastava Joshi may kindly look into this. A brainstorming session to develop relevant tools and SOPs is planned for the next OC meeting.
- 5. The Committee recommended that gender-disaggregated data should be included in the reports submitted by PRs.
- 6. It was discussed that core responsibilities among OC members should be distributed equitably to ensure balanced involvement and to prevent overburdening a few individuals.
- 7. The Committee discussed the need to bring a unique value to its reviews and field visits to enhance oversight and demonstrate the value of the Oversight Committee's role.
- 8. A physical debrief meeting regarding the C19 RM and GC7 PR Desk Review was proposed for April 2025. However, it was noted that this is subject to approval, given the transition in leadership and the ongoing process for a no-cost extension of India CCM activities.
- Sikkim and Himachal Pradesh were proposed as the next states for OC field visits, with Tamil Nadu selected as a backup option.



10. The 10th virtual Oversight Committee meeting is scheduled to be held on 21st May 2025.
